Public Risk Management Awareness Day



In case you haven't heard, March 1st is officially Public Risk Management Day! The goal is to bring a heightened level of awareness and education throughout communities by giving public risk management a platform to use to create special activities, proclamations and publications commemorating every March 1st as Public Risk Management Awareness Day! Texas PRIMA is promoted the day on the www.texasprima.org website, community forum, in this newsletter and on our social media platform. You can find a toolkit on the website that has a sample resolution, the logo, logo use guidelines, and a written description of the awareness day. The day can be found on the National Archive Day website at www.NationalDayArchives.com. National PRIMA promoted the awareness day also.

I've heard from many of our members across the state on how they celebrated the day in their own entities. In Corpus Christi,

we've had resolutions adopted by the Port of Corpus Christi and Nueces County. The City of Corpus Christi has approved a proclamation recognizing the awareness day.

Governor Abbott signed a proclamation inaugurating March 1st as Public Risk Management Awareness Day! The proclamation was sponsored by Representative Abel Herrero and read in the House Chambers of the Capital on Wednesday, February 27, 2019! Several Texas PRIMA Members were in attendance, including Donna James-Spruce, Martha Valderama and Mariza Rodriguez with the Port of Corpus Christi, Cindy Conyers with City of San Marcos, Melissa Steger with the University of Texas System, Robert Warren with the City of Arlington, and Leslie Milvo with the City of Austin.



Creative rationale for the logo is that the star is the base for the logo, representing Texas, the state in which the Public Risk Management Awareness Day originated. The five points of the star abstractly represent the five stages/processes of the enterprise risk management process model; scan environment, identify risks, analyze risks, treat risks, monitor and assure. The colors and reversed wave are a subtle representation of the Port of Corpus Christi, who initiated the day of awareness for public risk management.

Why a Public Risk Management Awareness Day?

The question that surrounds many individuals who do not work in Risk Management is: What is Risk Management? If you are reading this article, you know how complex the response to this question can be. There certainly can be an unspoken gap between every department in an organization and Risk Management. The Director of Risk Management at the Port of Corpus Christi recognized this gap and has established a platform in which to provide the opportunity to bridge the gap within the organizations of public entities all around Texas. Mrs. Donna James-Spruce, along with her staff, established the Public Risk Management Awareness Day as March 1st in the National Day Archives. Furthermore, on a more local level, Mrs. James-Spruce initiated the adoption of a Resolution for this awareness day on February 12, 2019 from the Nueces County Commissioner's Court. Additionally, the Port of Corpus Christi adopted the same Resolution on February 19, 2019 at their Commissioners meeting. The City of Corpus Christi followed suit and adopted the Proclamation at their City Council meeting on February 26, 2019. This fierce team didn't stop there, they contacted State of Texas Representative Mr. Abel Herrero's office to have a Resolution read in their District at the State Capital during the legislative session on February 27th. Even though the Port of Corpus Christi's team did the leg work to establish this platform for educational and engagement opportunities, they have extended the invitation to neighboring public entities including the Risk Management team at the City of Corpus Christi, Nueces County and the Corpus Christi ISD for recognition at these meetings and encourage all public entities around Texas to do the same! Let's stand together to recognize and bring awareness to Public Risk Management, whether a city, county, port authority, school district, or other governmental entity, each has a unique set of inherent risks.



Surrounding public entities also scheduled with their own Mayors and City Councils in recognizing this day, and you can as well. On behalf of the Port of Corpus Christi Risk Management team, we encourage you to engage with your local jurisdictions and request Proclamations and/or Resolutions for the Public Risk Awareness Day of March 1st. You have a whole year to prepare and make those connections. Texas PRIMA has provided a Public Risk Management Day toolkit on their website to help jumpstart your efforts in commemorating this day within your local government. See www.texasprima.org. National PRIMA is promoting the day and Texas PRIMA has also used its social media campaign to spread the word!

Supporting Employers in Managing an Aging Workforce

Why Is Our Workforce Aging and Why Are They Still Working?

Statistics indicate that 40% of those over the age of 55 are working. Beyond that, the baby boomers are a large segment of our population with 10,000 in the U.S. turning 65 every day! It is estimated that within the next decade 40% of the U.S. labor force will be eligible for retirement. At the same time, the retirement age is gradually changing to 70 years old, and as many as 75% of older adults expect to work after age 70. Why? Many of these workers do not have adequate savings to support themselves in the lifestyle to which they have become accustomed in retirement. Other older workers simply want to continue to work in some capacity after reaching the typical retirement age, and still others want put off taking social security to maximize these benefits.

What Are The Effects Of Aging?

This will not come as a surprise to anyone. The effects of aging are apparent to many and here are some: decreased strength and range of motion, decreased movement and speed, loss of vision and hearing, decreased spatial sense, and cognitive changes. These changes are coupled with an increase in chronic

conditions such as hypertension, arthritis, diabetes, and heart problems. The top 5 types of injuries that impact aging workers are: rotator cuff sprains, lumbar disc disease, brain injuries, carpal tunnel syndrome, and knee cartilage injuries.

How To Keep Our Aging Workers Safe

Some solutions are: reduce heavy lifting; reduce static standing time; improve working surfaces; improve illumination; review office ergonomics; eliminate work on ladders; avoid above the shoulder work; and keep floors clear, dry, and cushioned.

Claims Management

Gather as much medical and activity information as possible and use the same process regardless of the age of the injured worker. Remain in conversations with your employees and focus on function, not pain. Early intervention is the key to success. And lastly, follow up with them!


